Community Council Elections



In November 2018, 30 out of 42 Community Councils successfully formed across the local authority area, establishing a formal tier of local democracy to represent the voices of local people in their communities.

However, there were 12 areas where sufficient numbers were not achieved to form a Community Council. Those villages and areas have now been given a second chance to gain representation, by submitting nominations **no later than Friday 8 February at 4pm**.

Community Councils are involved in a wide range of activities and issues, including planning and licensing applications, bringing inspiring projects to life and passing on expertise.

Anyone over the age of 16, and on the electoral register for their community council area, can stand for election and get involved in a rewarding role which will ensure communities have a voice. Nominees need a proposer and seconder who both must be on the electoral register and live in the same Community Council area. Consultation on Scottish Charity law

This Scottish Government consultation seeks views on potential improvements to the statutory charity regulation framework in Scotland, in light of proposals put forward by the Office of Scottish Charity Regulator (OSCR).

The proposals broadly focus on improvements to charity law that would increase transparency and accountability in order to maintain public trust and confidence in charities and OSCR.

It has been 17 years since the Scottish Charity Law Review Commission (the 'McFadden report') proposed establishing a new regulator for Scotland and more than 13 years since the passage of the Charities and Trustee Investment (Scotland) Act 2005, which forms the basis of the legislative framework for charities in Scotland.

Given the passage of time since the Act was passed, and the changing environment that charities are operating in, Scottish Government feels the time is right to check how well the current arrangements are working and to explore potential improvements.

Views are sought from members of the public, the charity sector, and anyone with an interest in charity law. Scottish Government wants to learn from the charity sector's expertise and experience and hear first-hand about what really makes an impact on levels of public trust and confidence.

Scottish Ministers remain committed to the concept and reality of Scotland as a Good Food Nation.

A great deal of work is already happening now to make a real and positive difference to the lives of the people of Scotland: helping to improve their access to and understanding of the benefits of healthy local foods; ensuring sustainability of our wonderful food industry; and looking to grow Scotland's reputation as a Good Food Nation from which other countries can learn.

Scotland is well on its way to becoming a Good Food Nation, as the Programme of Measures published in September 2018 demonstrates. While legislation is not the **only** way to make progress, Scottish Government recognises that there is a clear place for legislation to underpin the considerable work that is already being done to realise our Good Food Nation ambitions.

This consultation sets out proposals for legislation around the Good Food Nation ambition.

The Prince's Countryside Fund

Communities running projects to tackle rural isolation are invited to apply for grants of up to £25,000. This dedicated programme of support for community projects in England, Scotland and Wales is funded by Players of People's Postcode Lottery. Woodward Charitable Trust – Childrens Summer Playschemes

Each year the trustees of the Woodward Charitable Trust set aside funds for summer playschemes for children between the ages of 5-16 years. Programmes must run for a minimum of 2 weeks or 10 days across the summer holidays.

Grants can only be paid to registered charities. Most grants awarded are in the range of £500 to £1,000. Around 35 grants are made each year. Preference is given to:

- small local playschemes that provide a wide-ranging programme of activities
- schemes that involve a large number of children
- schemes catering for those from disadvantaged backgrounds or that have a disability
- schemes that are inclusive such as projects that work with children from a range of backgrounds, abilities and race
- schemes where past users are encouraged to come back and help as volunteers

Launch of Communities Defeat Terrorism cinema campaign



Police Scotland is highlighting the important role communities play in the fight against terrorism by supporting the latest UK wide Action Counters Terrorism campaign which launched on Wednesday 23rd January, with Counter Terrorism Policing launching a new public information film 'Look Again' which will be shown in UK cinemas and across Police social media accounts.

The campaign will last 8 weeks and is timed to coincide with Oscar's season. Using cinemas will allow Police to deliver our messaging with fewer distractions, more impact and targeting harder to reach audiences such as young people.

The sequel to last year's 'Communities Defeat Terrorism' campaign will feature a new 60-second film based on real-life foiled plots, which will show examples of terrorist-related suspicious activity and behaviour, as well as attack planning methodology.



Airing across 120 cinemas nationwide, including 16 in Scotland, for the next eight weeks, the film will encourage people to report suspicious behaviour and activity through www.gov.uk/ACT and the confidential hotline - 0800 789 321.

Launch of Communities Defeat Terrorism cinema campaign

Assistant Chief Constable Steve Johnson, Police Scotland's lead for specialist crime and Intel, said: "Tackling terrorism and domestic extremism is a national priority for Police Scotland and we will continue to work with our partners to protect our communities.

"We should never be complacent and the UK threat level remains at severe, meaning an attack is highly likely.

"I hope this campaign reinforces how important it is for communities to act if they see anything suspicious in their area.

"The video asks people to stop and think if they see unusual behaviour and trust your instincts. The unusual behaviour could be part of a bigger picture so it's crucial people feel confident enough to report this to police. Let us decide how important it is and never think it could be a waste of our time."

Assistant Commissioner of Specialist Operations (ACSO), Neil Basu, the UK's most senior counter terrorism officer, said: "Thankfully, we did not see the horrors of 2017 repeated last year, but we should not be complacent enough to think the terrorist threat has diminished.

"Counter Terrorism Policing officers are currently running more than 700 live investigations nationwide, while crucial intelligence from the public has helped police and the security services prevent 18 terror attacks in just under two years.

"We have been emphasising for some time that communities defeat terrorism, and the fact that more and more reports from the public provide information that is useful to our officers demonstrates this.

"Despite this increasing support, I know some people are still reluctant to speak to us. To them I say, reporting your concerns to us won't ruin lives, but it might save them.

"Like other criminals, terrorists need to plan and that creates opportunities for police and the security services to discover and stop these attacks before they happen.

"But we need your help to exploit these opportunities, so if you see or hear something unusual or suspicious trust your instincts and **act** by reporting it in confidence by phone or online.

"That could be someone buying or storing chemicals, fertilisers or gas cylinders for no obvious reasons, or receiving deliveries for unusual items, it could be someone embracing extremist ideology, or searching for such material online.

"This new film has been made to try and help people understand recent terrorist attack-planning methods."

Launch of Communities Defeat Terrorism cinema campaign

Previous national campaigns, which have been amplified at a local level, have helped increase intelligence reports by up to 50 percent. Currently over a fifth of public reports to the Anti-Terrorist Hotline and online through gov.uk/ACT result in useful intelligence for CT officers. There is a tangible and potentially lifesaving impact as a result of public support.

We are inviting partners and stakeholders to promote the campaign and encourage the public to report suspicious activity.

We have prepared a toolkit for the use of you, our partners, which will be updated throughout the eight weeks campaign. Messaging can be done to suit your own organisation and around any of your own planned announcements.
