### **Permanent Closure of Croftamie Nursery**

On 25 April 2019, Stirling Council's Children and Young People Committee agreed to a formal consultation to consider the permanent closure of Croftamie Nursery under the Schools (Consultation) (Scotland) Act 2010.

**The consultation period will run from Friday 26 April to Friday 7 June 2019.** This is the period allowed for the statutory minimum of 30 school days.

## **Licensing (Scotland) Act 2005 – Review of Occasional licences**

**The Scottish Government is reviewing the fee for occasional licences and considering a limit on the number and duration of occasional licences.**

The alcohol licensing regime is administered by Licensing Boards. The Boards carry out a range of functions including granting and reviewing licences. The regime operates on a cost recovery basis, with Board costs being covered by fees, including licence fees.

The purpose of the occasional licence is to cater for the multitude of events which take place on premises which are not 'fully' licensed but feature the sale of alcohol, for example fetes, wedding receptions and arts events. When used in their envisaged role, occasional licences offer a flexible regime for the hospitality and entertainment sector to provide alcohol at events outside licensed premises. However, concerns have been raised that some applicants have sought to use the occasional licence process to apply for consecutive occasional licences as an alternative to a full premises licence. Allowing them to circumvent parts of the licensing regime.

The purpose of the consultation is to consult on whether to raise the fee for an occasional licence from the current price of £10, and if it is agreed that the fee should increase, seek views on what that new fee level should be; and seek views on considering a limit on the number and duration of occasional licences for premises licence holders and personal licence holders.

## Strengthening Community Councils



The Scottish Community Development Centre (SCDC) and What Works Scotland have released their Strengthening Community Councils report. The report explores how community councils can be even more relevant in Scotland's evolving policy context, especially as public service reform continues through the Local Governance Review.

SCDC heard from more than 600 people involved in community councils about the role they play in the democratic landscape - and what could change to improve how they represent local communities going forward.

## Updated Guidance on Charity Accounting

The Office of the Scottish Charity Regulator (OSCR) has updated its guidance on the legal requirements for preparing charity accounts and getting those accounts externally scrutinised. The legal requirements have not changed but the updated guidance aims to help charity trustees better understand the requirements. All of a charity's trustees are responsible for the preparation of the charity's accounts, even if they are not accountants or financial experts. So it's important that the guidance is accessible to all trustees.

OSCR advise that before you begin to prepare your charity's accounts, you should read **A Guide to Charity Accounts**. This guide explains the type of accounts that your charity should prepare and the kind of external scrutiny of the accounts that is required.



The report explores a number of features of the digital inclusion debate including analysing the components that comprise appropriate digital access, examines the impacts around a lack of access, maps exclusion factors in the UK and outlines the current policy and practice landscape, including successful interventions.

## Investing in Communities Fund

The Investing in Communities Fund is open for applications from Tuesday 7th May 2019 until the deadline of Friday 14th June 2019 and is delivered as part of the Empowering Communities Programme. This is a new streamlined communities fund to tackle disadvantage, poverty and inequality that encourages community-led development, design and delivery of sustainable local solutions addressing local issues, circumstances and aspirations across a broad range of community led activity.

Grants of up to £250,000 are available over three years providing stability and recognising the need for longer term planning in some projects.

## Eat Well Age Well - Small Ideas, Big Impact Fund

Eat Well Age Well aims to reduce the number of older people who are at risk of becoming malnourished, or already are hungry and malnourished.

The organisation want people to think outside the box and come up with innovative ideas that will help support older people to eat well and combat malnutrition. Your ideas could be to help support an existing project or it could be to implement a completely new initiative. Before applying, applicants should consider:

- What needs have been identified in your local area?
- What food/befriending activities are already in place?

Have any gaps been identified for morning/afternoon/evening or weekend support and activities

Applicants can apply for funds ranging from £50 to £5000 to test ideas which will prevent, detect and/or treat malnutrition.

Submissions for Round 2 of the Small Ideas, Big Impact Fund will be open from Monday 6 May 2019 until **Friday 2 August.**
