# Stirling's Pontoon Launched

The first wave of boats are taking to the water as Stirling's new pontoon launches from the heart of the city. Both recreational and commercial boat operators can now book online via the <a href="Council website">Council website</a> to gain access to the River Forth

The new Shore Road pontoon is aiming to make the River Forth a key feature for the city again for the first time since the 1940s. The pontoon landing stage is 30 metres long, with an additional five metre section for rowing boats and kayaks. The state-of-the-art pontoon and access walkway rise and fall with the tide and is designed to be wheelchair compliant.



# Stirling Council's Preloved Clothing Platform Launched

The pre-loved clothing online platform is to be carried out in three phases:

- Phase One School session 2019/2020 including nurseries and primary schools
- Phase Two School session 2020/2021 extending to high schools
- Phase Three School session 2020/2021 begin to include prom dresses and prom suits.

# Consultation on the Right to Buy Land to Further Sustainable Development

The Scottish Government is consulting on regulations to bring into force Part 5 of the Land Reform (Scotland) Act 2016, the right to buy land to further sustainable development. It is important that those who may seek to use Part 5 to buy land, and those whose land may be sought under Part 5, have the opportunity to comment on how the Part 5 process will work in practice. In addition to asking about the detail of the regulations, the consultation contains an overview of how the Part 5 process will work. This is an opportunity for consultees to consider and comment on whether this matches their expectations of how the Part 5 legislation would work in practice

# **Scottish Land Commission seeks Community Views**

The Scottish Land Commission has launched a new survey seeking views of communities across Scotland about community engagement in decisions relating to land.



Forth Valley

The Commission wants to make sure that all people in Scotland have the opportunity to be involved in decisions about land that significantly affect them. The Commission is supporting communities, land owners and land managers to work together to make better – and fairer – decisions about land use with the publication of its first Protocol on Community Engagement in Decisions Relating to Land.

The Commission's Protocol supports the Guidance on engaging communities in decisions relating to land, which was published by the Scottish Government in April last year. Over the next couple of years, the Commission will review the effectiveness of the guidance, and recommend improvements if needed. The survey will establish a baseline against which progress can be measured and identify where further support needs to be developed by the Commission or other organisations.

#### **Funeral Director: Code of Practice Consultation**

The Scottish Government is consulting on a statutory Funeral Director: Code of Practice. Funeral directors will be inspected against this Code once it comes into force and will be legally obliged to meet its requirements.

The Code was developed with input from a funeral director industry working group, chaired by the Inspector of Funeral Directors, and including funeral director representatives. It is important the people who will be affected by the Code are given the opportunity to comment on all aspects of the content of the Code, so that Scottish Government can understand the impact it will have on funeral directors and the funeral industry

# Festival of Volunteering Co-production Group

Stirlingshire Voluntary Enterprise (SVE) has set up a Festival of Volunteering Co-production Group so that smaller local Volunteering Involving Organisations can contribute to the Festival of Volunteering in September 2019 and the Festival year in 2020. The Co-production Group will feed directly into the Festival Steering Group.

The meetings include updates on The Festival of Volunteering as well as information about the Inspire Volunteering Award Ceremony, which will be held on Tuesday 3 September 2019.

The Group will look at ways that smaller organisations, who may not have the resources for an event, can celebrate their volunteers. One example of this is The Volunteering Tree. This is where volunteering organisations can add short quotes on paper leaves about their volunteers, and service users can talk about how volunteers makes a difference to them, or volunteers can add something about how volunteering has made a difference to them. The leaves are then added to a wooden tree. In 2018, SVE also produced a book, highlighting a few of the 400 quotes that were added to the tree.

SVE are also hosting a Story of Volunteering. This is an opportunity for organisations to send images, quotes, stories, photographs, videos or any visual representations that reflects their organisation. These will be collated to give an insight into volunteering in the Stirling and Forth Valley area.

# 16 Days of Action Again Violence
